“The Collaborative Life Skills Program: An Evidenced- Based School- Home Intervention for Attention and Behavior Challenges”

Youth with attention and behavior problems present with multiple challenges at school and at home. All too often school services for these youth are inadequate and clinic-based services have limitations in terms of accessibility and generalization of treatment effects. To address these concerns, we developed the Collaborative Life Skills Program (CLS). Administered by a school-based mental health provider, CLS provides skill training for students and simultaneously trains teachers and parents to implement specific strategies for promoting the student's success across the school and home settings. All components are integrated to support generalization and cross-situational treatment effects. This presentation will describe the origins and conceptual basis of CLS, the key intervention components, and the methods for training school mental health providers. Recorded video demonstrations of CLS training components will be presented and discussed. The latest findings from open trials and a recently completed randomized trial of CLS will be presented along with our current efforts to develop a web-based remote training platform for clinicians.
